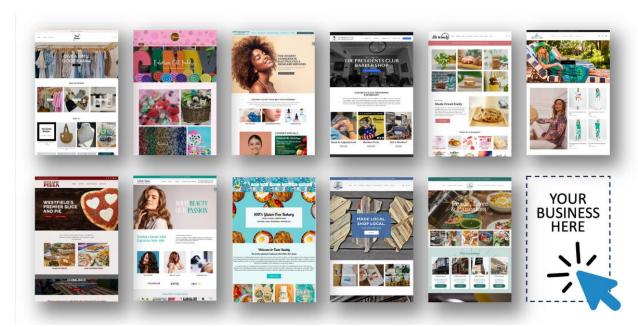

Ordinance Appropriating \$775,000 from the Sewer Trust Fund to Provide for Various Sewer Improvements in and by Princeton, in the County Of Mercer, New Jersey (Public Hearing August 11, 2025)- Roll Call

#### **ORDINANCE** #2025-12

ORDINANCE APPROPRIATING \$775,000 FROM THE SEWER TRUST FUND TO PROVIDE FOR VARIOUS SEWER IMPROVEMENTS IN AND BY PRINCETON, IN THE COUNTY OF MERCER, NEW JERSEY.

BE IT ORDAINED BY THE COUNCIL OF PRINCETON, IN THE COUNTY OF MERCER, NEW JERSEY AS FOLLOWS:

Section 1. \$775,000 of the amount previously appropriated by Bond Ordinance #2025-07, finally adopted March 24, 2025 ("Bond Ordinance #2025-07"), is hereby appropriated by Princeton, in the County of Mercer, New Jersey ("Princeton") from the Sewer Trust Fund to provide for various sewer improvements, including the acquisition of a jetter truck (in the amount of \$455,000), the Sanitary Sewer Evaluation Survey (in the amount of \$105,000) and miscellaneous sewer operation facility repairs and improvements (in the amount of \$215,000), each including all related costs and expenditures incidental thereto and further including all work and materials necessary therefor and incidental thereto.

Section 2. Princeton hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of Princeton is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. As a result of the appropriation made in Section 1, (i) the down payment provided for in Section 1 of Bond Ordinance #2025-07 is hereby reduced by \$38,750, from \$668,149 to \$629,399, (ii) the amount of bonds and bond anticipation notes authorized by Bond Ordinance #2025-07 is hereby reduced by \$736,250, from \$12,694,770 to \$11,958,520, and (iii) Section 3(g)(1) through (3) of Bond Ordinance #2025-07 are hereby amended in their entirety to read as follows:

g) Infrastructure 1) The acquisition of a jetter truck for the Sewer Operating Department and the acquisition of compactor trucks, a dump truck with plow and sander and a mason dump body truck for the Department to Public Works, including all related costs and expenditures incidental thereto.	\$1,473,000 (including \$455,000 from the Sewer Trust Fund)	\$967,100	10 years
2) The Sanitary Sewer Evaluation Survey, including all work and materials necessary therefor and incidental thereto.	\$105,000 (including \$105,000 from the Sewer Trust Fund)	\$0	N/A
3) Miscellaneous sewer operation facility repairs and improvements and repairs to 380 Witherspoon Street (Recreation Building) and Witherspoon/Monument Building, including all work and materials necessary therefore and incidental thereto.	\$366,000 (including \$215,000 from the Sewer Trust Fund)	\$143,450	15 years

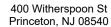
Section 4. Section 6(b) of Bond Ordinance #2025-07 is hereby amended in its entirety to read as follows:

"The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 10.80 years."

Section 5. The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of Princeton as defined in the Local Bond Law is reduced by the reduction in the amount of bonds and bond anticipation notes originally authorized by Bond Ordinance #2025-07 as amended hereby, by \$736,250, from \$12,694,770 to \$11,958,520, and the obligations authorized herein will be within all debt limitations prescribed by that Law.

Section 6. Except as set forth herein, the remaining provisions of Bond Ordinance #2025-07 remain in full force and effect.

Section 7. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

#### **ORDINANCE #2025-13**

An Ordinance by the Municipality of Princeton Designating No Turn on Red Intersections and Amending Chapter 19 of the "Code of the Borough of Princeton, New Jersey, 1974".

WHEREAS, Princeton has adopted a Vision Zero Policy that seeks to eliminate crashes that result in serious injury or fatalities; and

WHEREAS, in order to achieve that goal, reducing conflicts between motorists, bicyclists, and pedestrians is a proven safety measure; and

WHEREAS, buffered bicycle lanes will be installed on North Harrison Street between Clearview Avenue and Terhune Road under a pilot project approved by Council; and

WHEREAS, prohibiting right turns on red signals will remove the conflict between bicyclists in the bike lanes and motorists attempting to cross over the bike lanes at the Valley Road, Princeton Shopping Center, and Terhune Road intersections with North Harrison Street; and

WHEREAS, prohibiting right turns on red signals will remove the conflict between pedestrians, particularly school children, at the North Harrison Street intersections with Hamilton Avenue and Franklin Avenue; and

WHEREAS, the prohibition of right turns on red signals has been implemented by signage at various intersections throughout Princeton, and at this time Council seeks to implement same more uniformly by ordinance as well.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of Princeton as follows:

<u>Section 1.</u> No Turn on Red intersections amended. Subsection B19-13.2 of the Code of the Borough of Princeton, New Jersey (1974), which prohibits right turns upon a stop or caution

signal at certain intersections, is hereby amended as follows (new text is underlined <u>thus</u>; deleted text is in brackets [thus]):

- (a) No turn on red.
  - (1) At certain intersections prohibited. In accordance with N.J.S.A. 39:4-115, right turns upon a "stop" or "caution" signal in the following street intersections within the jurisdiction of [the borough] <u>Princeton</u>, where traffic is controlled by traffic control signals, are hereby prohibited as indicated:

Alexander Street and Faculty Road. For traffic northbound on Alexander Street turning right (east) onto Faculty Road.

Harrison Street and Hamilton Avenue. For traffic eastbound on Hamilton Avenue and turning right (south) onto Harrison Street.

<u>Harrison Street and Nassau Street.</u> For traffic northbound on <u>Harrison Street turning right (east) onto Nassau Street.</u>

<u>Harrison Street and Nassau Street.</u> For traffic southbound on Harrison Street turning right (west) onto Nassau Street.

<u>Harrison Street and Hamilton Avenue.</u> For traffic westbound on Hamilton Avenue and turning right (north) onto Harrison Street.

Harrison Street and Hamilton Avenue. For traffic southbound on Harrison Street turning right (west) onto Hamilton Avenue.

<u>Harrison Street and Hamilton Avenue.</u> For traffic northbound on Harrison <u>Street turning right (east) onto Hamilton Avenue.</u>

<u>Harrison Street and Franklin Avenue.</u> For traffic eastbound on <u>Hamilton Avenue and turning right (south) onto Harrison Street.</u>

<u>Harrison Street and Franklin Avenue.</u> For traffic westbound on <u>Hamilton Avenue and turning right (north) onto Harrison Street.</u>

<u>Harrison Street and Franklin Avenue. For traffic southbound on Harrison Street turning right (west) onto Franklin Avenue.</u>

<u>Harrison Street and Franklin Avenue.</u> For traffic northbound on Harrison Street turning right (east) onto Franklin Avenue.

<u>Hodge Road and Bayard Lane.</u> For traffic eastbound on Hodge Road and turning right (south) onto Bayard Lane.

North Harrison Street and Valley Road. For traffic northbound on North Harrison Street and turning right (east) into the Princeton Shopping Center.

North Harrison Street and Valley Road. For traffic southbound on North Harrison Street and turning right (west) onto Valley Road.

North Harrison Street and Valley Road. For traffic westbound from the Princeton Shopping Center and turning right (north) onto North Harrison Street.

North Harrison Street and Valley Road. For traffic eastbound on Valley Road and turning right (south) onto North Harrison Street.

North Harrison Street and Terhune Road. For traffic northbound on North Harrison Street and turning right (east) onto Terhune Road.

North Harrison Street and Terhune Road. For traffic eastbound on Terhune Road and turning right (south) onto North Harrison Street.

Paul Robeson Place and Bayard Lane. For traffic westbound on Paul Robeson Place and turning right (north) onto Bayard Lane between the hours of 7:00 am and 7:00 pm.

Washington Road and Prospect Avenue. For traffic westbound on Prospect Avenue turning right (north) onto Washington Road.

Witherspoon Street and Paul Robeson Place. For traffic southbound on Witherspoon Street turning right (west) onto Paul Robeson Place.

Witherspoon Street and Paul Robeson Place. For traffic eastbound on Paul Robeson Place turning right (south) onto Witherspoon Street.

Witherspoon Street and Wiggins Street. For traffic northbound on Witherspoon Street turning right (east) onto Wiggins Street.

Witherspoon Street and Wiggins Street. For traffic westbound on Wiggins Street turning right (north) onto Witherspoon Street.

### (2) Signs required.

a. Official signs pursuant to N.J.S.A. 39:4-198 shall be placed at the aforesaid intersections prohibiting said turns.

Section 2. The appropriate signs shall be posted in accordance with the Manual on Uniform Traffic Control Devices to implement the requirements of this ordinance.

<u>Section 3.</u> All ordinances or resolutions or parts thereof inconsistent with this ordinance are repealed to the extent of such inconsistency.

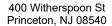
Section 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portion thereof.

Section 5. This ordinance shall take effect upon its adoption and publication in accordance with law, and if necessary, also upon approval of the Commissioner of the New Jersey Department of Transportation.

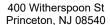

WHEREAS, by Resolution 24-354 adopted on December 9, 2024, Princeton Council authorized a contract with WeDriveU, Inc. for the Operation and Maintenance of the Princeton Transit Service in 2025 for an Amount Not to Exceed \$377,164.00; and

WHEREAS, additional transportation services have been requested which require an adjustment to the authorized schedule; and

WHEREAS, WeDriveU, Inc. has agreed to an increase of \$1,500.00 per month for August 2025, through December 2025, resulting in an overall contract increase of \$7,500.00 and a new Amount Not to Exceed \$384,664.00; and

WHEREAS, all other terms and conditions of the contract will remain unchanged; and

**WHEREAS**, the Chief Financial Officer has certified that sufficient funds are available in account 05-201-02-009-299.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of Princeton, County of Mercer, State of New Jersey, as follows:

- 1. Subject: Proposed Pilot Service and Amendment to the Princeton Municipal Transit Services (The Muni) Contract

**Date:** July 28, 2025

Attached for consideration by Council at the July 28, 2025 Council meeting is a resolution to amend WeDriveU, Inc.'s transit service contract with Princeton to increase the service hours for a pilot commuter service effective August 1, 2025.

Currently, WeDriveU operates an 80-minute fixed route service from 8 am to 9 pm Monday through Saturday. It is proposed that a commuter route be implemented during the hours of 6 am to 8 am and 6 pm to pm Monday through Friday. The proposed increase to the service time of 15 hours per week will cost \$1,500 per month. The commuter service will run between the Princeton Shopping Center (an informal transit hub) and Princeton Station (the Dinky) during morning and evening commuting hours.

The demand for a connection between the Princeton Shopping Center and the New Jersey Transit Northeast Corridor was identified during the Nelson Nygaard transit study outreach. We have also received requests directly from management of The Alice to provide a direct connection to the train for their tenants. Similarly, Avalon has indicated that this would be of benefit to their tenants at Avalon Thanet Circle and Avalon on Harrison. Management of the residential communities will assist in promoting this service to their tenants.

We have negotiated this pilot to run for the remainder of the year in order to evaluate whether a permanent service is justified. The shuttle will run three times in the morning and four times in the evening between the hours of 6:00 am and 8:00 am and 6:00 pm and 9:00 pm. Between 8:15 am and 5:45 pm, the Muni will make its normal stops and continue to run the 80-minute loop. If at any time during the pilot, ridership does not support this service, it can be canceled with two weeks' notice.

The Engineering Department recommends approval of the resolution to amend the transit services contract to WeDriveU, Inc. for up to \$7,500.

#### TRANSIT SERVICES AGREEMENT AMENDMENT

The following Amendment to the 2025 Transit Services Agreement, by and between Princeton, a municipal corporation of the State of New Jersey, and WeDriveU, Inc., is effective as of August 4, 2025 (deletions are marked with brackets thus [] and additions are underlined)

#### 7. Service Schedule of Operation

The Contractor shall operate the Princeton Transit Service Monday through Saturday between the hours of [7:30 am and 8:30 pm] 6:00 am and 9:00 pm, except for the following holidays and / or holiday observances:

- Monday, January 1, 2025, New Year's Day
- Monday, May 26, 2025, Memorial Day
- Friday, July 4, 2025, Independence Day
- Monday, September 1, 2025, Labor Day
- Thursday, November 27, 2025, Thanksgiving
- Thursday, December 25, 2025, Christmas Day

In the event of inclement weather such as snow, ice or hurricanes which threaten the safe operation of the Services, the Municipality reserves the right to direct the Contractor to modify or cancel the schedule.

#### 8. Route Description

The Contractor shall provide a fixed route service between the Princeton Shopping Center at 301 North Harrison Street and the Princeton Station ("Dinky") at 210 Alexander Street between the hours of 6:00 am and 8:00 am and between the hours of 6:00 pm and 9:00 pm AND a fixed route between the hours of 8:15 am and 5:45 pm as described herein as the "Schedule 1 – Primary Route". Provided below are the location of stops for the Princeton Transit Service Schedule 1 – Primary Route. The Contractor shall determine the sequence of the stops and schedule to optimize the route(s) for efficiency in order to ensure a maximum route time of [70] 80 minutes. Where available, the stops shall be at existing bus shelters and the route(s) shall be scheduled to interconnect, to the greatest extent practicable, with New Jersey Transit (NJT) and the Princeton University Tiger Transit services at the locations identified below. Princeton reserves the right to modify the route and schedule in consultation with and as agreed to by the Contractor (e.g.; to suspend the fixed route between the Princeton Shopping Center and the Dinky on Saturday).

SCHEDULE 1 – Primary Route – the primary route is the base route to be serviced.

- Elm Court, 300 Elm Drive
- Harriet Bryan House, 310 Elm Drive

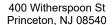

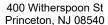

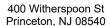

**WHEREAS**, the Municipality of Princeton (the "Municipality") is the owner of the former Westminster Choir College campus and the improvements thereon, located at 101 Walnut Lane, Princeton, New Jersey, and designated on the municipal tax maps as Block 31.01, Lot 105 (the "Campus"); and

WHEREAS, the McCarter Theatre Company, a New Jersey nonprofit corporation that is recognized by the Internal Revenue Service as a 501(c)(3) organization ("McCarter"), desires to acquire a portion of the Campus (the "Property"); and

WHEREAS, McCarter intends to use the Property to expand its community arts education programs, artistic programs and performances, gatherings and events, in order to invite Princeton community members of all backgrounds to participate in arts learning and performance; as well as to support and provide temporary short-term lodging to guest artists and arts professionals associated with the company's mission-driven work (the "Project"); and

### LETTER OF INTENT

This Letter of Intent (the "LOI") is made as of the Effective Date, as this term is hereinafter defined, by and between the McCarter Theatre Company, a New Jersey nonprofit corporation, with an address at 91 University Place, Princeton, New Jersey 08540 ("McCarter") and the Municipality of Princeton, a New Jersey municipal corporation, with an address at 400 Witherspoon Street, Princeton, New Jersey 08540 (the "Municipality"). McCarter and the Municipality are sometimes collectively referred to herein as the "Parties" and individually as a "Party."

### WITNESSETH:

Whereas, the Municipality has recently acquired the fee title to the former Westminster Choir College campus and the improvements thereon, known and designated Block 31.01, Lot 105 on the Municipality Tax Map, with a street address of 101 Walnut Lane, Princeton, New Jersey 08540 (the "Campus"), with the intent to cause it to be preserved and redeveloped for the benefit of the community; and

Whereas, both the Municipality and McCarter share the guiding value of preserving the artistic and educational core of the central campus, with the desire to redeploy some of the original buildings through adaptive reuse; and

Whereas, McCarter is exploring supporting this shared purpose by expanding its community arts education programs, artistic programs and performances, gatherings and events, in order to invite Princeton community members of all backgrounds to participate in arts learning and performance; as well as to support and provide temporary, short-term housing to guest artists and arts professionals associated with the company's mission-driven work (the "Project"); and

Whereas, in connection therewith, McCarter is making application to the New Jersey Economic Development Authority (the "EDA") for tax credits pursuant to the EDA's Cultural Arts Incentives (CAFE) Program (the "Program") to help fund said facility preservation, remediation, and improvements; and

Whereas, that portion of the Campus, consisting of the buildings, the land and the improvements thereon shown on <u>Exhibit A</u>, attached hereto and made a part hereof, is referred to in this LOI as the "Property"; and

Whereas, the Project is proposed to include the following on the Property: (a) the adaptive reuse of the Bristol Chapel with: a rehearsal space, arts education (including classrooms, a seminar room, lecture hall and practice room), administrative offices and a work area, production education and building support (all of which may be used to host community events for a fee); (b) the adaptive reuse of the Playhouse with a performance space, production support and building support (all of which may be used to host community events for a fee); and (c) adaptive reuse and new construction at the site of the Cottage building for short-term artist housing, which may also be used on a temporary, short-term basis by guests; and

Whereas, the Project aligns with the Municipality's long-term goals for the Campus; and

Whereas, as part of its broader plans for the Campus, the Municipality intends to rezone the Campus in such a manner that it will ensure the Project will be a permitted use thereon; and

Whereas, the municipality is aware that the CAFE Program requires the cultural arts institution to complete the project and obtain a TCO within four years of the cultural art institution executing the tax credit agreement with the EDA; and

Whereas, McCarter represents that it is a nonprofit corporation that is recognized by the Internal Revenue Service as a 501(c)(3) organization; and

Whereas, subject to the conditions set forth below in this LOI, McCarter desires to purchase the Property from the Municipality and the Municipality desires to sell the Property to McCarter for the implementation of the Project thereon; and

Whereas, this Letter of Intent was approved and the Mayor was authorized to execute it by Resolution \_\_\_\_\_, adopted by the Municipality's Council at its regular meeting on July 28, 2025.

Accordingly, this LOI summarizes the primary terms and conditions of a Purchase and Sale Agreement for the Property (the "PSA") to be entered into between the Parties as follows:

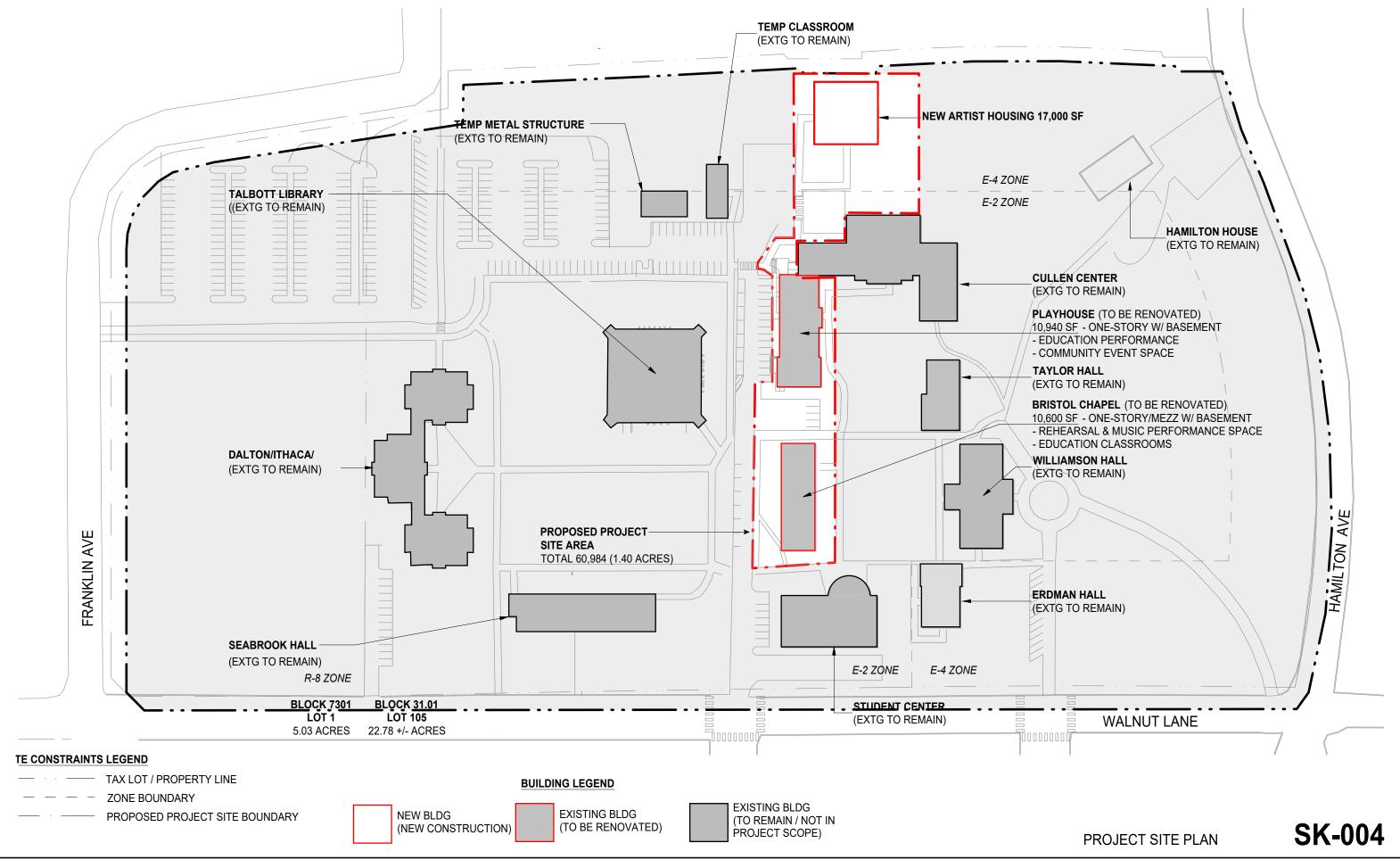
- 1. <u>Incorporation</u>. The preamble to and the recitals of this LOI are hereby incorporated into and made a part of this LOI as if set forth at length in this LOI.
- 2. <u>Property</u>. The Property is an approximately 1.40-acre portion of the Campus as shown in Exhibit A.
- 3. <u>Purchase Price</u>. The appraised purchase price to be paid by McCarter to the Municipality for the Property is approximately \$4,000,000, subject to increase if the Municipality obtains an alternate appraisal (the "Appraisal") establishing a higher value for the Property, provided that McCarter can terminate this LOI if the Appraisal exceeds an amount which McCarter determines renders the Project unviable in McCarter's sole and absolute discretion.
- 4. <u>Tax Credit Termination</u>. This LOI shall be automatically terminated if the EDA does not approve McCarter's application, pursuant to <u>N.J.S.A.</u> 34:1B-383 393 and <u>N.J.A.C.</u> 19:31BB-1.1 <u>et seq.</u>, to the EDA, made on or before August 11, 2025, and shall be terminable by McCarter if the EDA approves said application but at an amount of tax credits which McCarter determines makes the Project unviable in McCarter's sole and absolute discretion.
- 5. <u>PSA</u>. The Parties' obligations hereunder are subject to the Parties entering into the PSA on terms and conditions acceptable to each party in the sole and absolute discretion, which, among other things, shall include but not be limited to, the following provisions:
  - a. A provision for the allocation of and the timing of the payment Purchase Price,

- b. A title provision,
- c. A due diligence provision recognizing that the transaction shall be an "as-is, where-is" transfer in all respects including, without limitation, the environmental conditions of the Property,
- d. Provisions requiring the approval of the Municipality Council of any sale by McCarter of the Property without the Municipality's consent, and
- e. A provision requiring the Municipality Planning Board to hear and decide McCarter's application, pursuant to the Municipal Land Use Law, N.J.S.A. 40:55D-1 et seq., for preliminary and final site plan approval of the Project, within twelve (12) months of the execution of the tax-credit agreement with the EDA, as described in 6(f) of this LOI.
- f. Representations and warranties, and
- g. Such other provisions as are standard for purchase and sales agreements in the Princeton area as agreed upon by the parties.
- 6. <u>Conditions</u>. In addition to and not in limitation of the foregoing, each party's obligation to perform the PSA shall be conditioned upon the occurrence of all of the following:
  - a. The EDA approving McCarter's application to the EDA, pursuant to N.J.S.A. 34:1B-383 393 and N.J.A.C. 19:31BB-1.1 et seq., made on or before August 11. 2025, for an amount of tax credits to implement the Project, which McCarter determines makes the Project viable in McCarter's sole and absolute discretion.
  - b. The Municipality subdividing the Campus into one or more separate and tax lots forming the Property.
  - c. The Municipality determining that the Property is in need of rehabilitation pursuant to the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A-12A-1, <u>et seq.</u> ("LRHL") if the Property meets the criteria therefor.
  - d. The Municipality adopts a Redevelopment Plan for or otherwise rezones the Property to permit the construction and use of the Project thereon.
  - e. All of the governmental approvals required to construct and use the Project on the Property, including but not limited to, Municipality Planning Board approval of a site plan for the Project, the applications of which shall first be reviewed and

- approved by the Municipality, shall be received by McCarter within one year of the EDA board's approval of McCarter's application.
- f. McCarter's execution, within twelve (12) months of the EDA Board approval described in 6(a), of a tax-credit agreement with the EDA
- g. McCarter's demonstration that it has secured the necessary financing and/or possesses the required equity to commence construction of the Project within eighteen (18) months of execution of the tax-credit agreement with the EDA, as described in 6(f) of this LOI.
- h. Execution of the PSA by the Parties.
- 7. <u>PSA</u>. This Letter of Intent is nonbinding until the definitive PSA is executed and delivered by both parties.
- 8. <u>Effective Date</u>. The effective date (the "Effective Date") of this LOI is the date on which the later of the Parties to sign this LOI.

Resolution of the Mayor and Council Rejecting Bid for the Lease Of Public Property for a Wireless Telecommunications Facility at the Princeton Public Library and Authorizing Revisions to Bidding Materials and Re-Advertising the Lease

WHEREAS, Princeton is the owner of real property situate in Princeton with the street address of 65 Witherspoon Street, Princeton, New Jersey 08542, known as the Princeton Public Library, and referred to as Block 27.02, Lot 77 on the Princeton Tax Map; and

**WHEREAS**, pursuant to a duly advertised notice to bidders authorized by Resolution 25-164, Princeton received one bid for the lease of public property for a wireless telecommunications facility at the Princeton Public Library from Cellco Partnership d/b/a Verizon Wireless; and

WHEREAS, the bid received took several exceptions to terms of the bidding materials and the lease which are considered material and hence nonwaivable, most notably an exception to the conditions precedent for commencement of construction of the telecommunications facility as originally required in Resolution 25-164; and

WHEREAS, Resolution 25-164 and Princeton's bidding materials instructed bidders that conditional bids shall not be accepted, only immaterial informalities may be accepted and no material changes to the lease would be made after the bid opening; and

WHEREAS, at this time, the Engineering Department and Municipal Attorney's Office recommend that the bid received be rejected as nonconforming to the bidding requirements; and

WHEREAS, the Engineering Department has confirmed that a portion of the Princeton Public Library Building's rooftop and associated areas (the "Premises") remains suitable for the placement and operation of telecommunications antennas and associated equipment, Princeton does not have a need for public use of the Premises, and to that end, it is in the public interest for Princeton to amend the bidding materials and solicit new bids for such a lease.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Municipality of Princeton, County of Mercer, State of New Jersey, as follows:

- 1. The bid received on July 8, 2025 from Cellco Partnership d/b/a Verizon Wireless is hereby rejected for the reasons set forth in the foregoing "Whereas Clauses."
- 2. Pursuant to N.J.S.A. 40A:12-14(a), Princeton is hereby authorized and directed to solicit sealed bids for the Lease of the Premises, as identified above in the "Whereas" clauses, for purposes of designing, constructing and operating a wireless telecommunications facility on the Premises, at such time and place as may be deemed appropriate and necessary to effectuate the terms hereof.

- 3. Princeton shall cause said bidding to be duly advertised in accordance with the requirements of N.J.S.A. 40A:12-14, by causing the advertisement to be published in a newspaper circulating in Princeton by two (2) insertions at least once a week during two (2) consecutive weeks, the last publication to be not earlier than seven (7) days prior to the date of the bid opening. The advertisements and Bid Package shall be consistent with this Resolution. Said advertisement shall specify that Princeton reserves the right to reject all bids where the highest bid is not accepted.
- 4. The minimum terms and conditions as originally set forth in Resolution 25-164 adopted on April 28, 2025 shall govern the Lease between Princeton and the successful bidder, which are incorporated herein as if fully restated, except as follows:
  - a. Section 3F of Resolution 25-164's conditions regarding the timing for commencement of construction of the telecommunications facility and completion shall be replaced with the following:

The Lessee shall commence construction within 90 days of the Lessee's receipt of all government approvals necessary for the Lessee's use, which shall include approvals from any Federal, State or Local authorities having jurisdiction over the Lease as well as satisfactory environmental investigation, title search, or any other due diligence that will permit the Lessee's use under the Lease. Construction shall be completed within 120 days of commencement of construction, except that this time for completion shall be reasonably extended for good cause and/or if the Lessee is delayed for reasons beyond its reasonable control.

- b. The Engineering Department shall consider the remaining exceptions taken in the bid submitted on July 8, 2025 for purposes of making additional reasonable revisions to the bidding materials.
- 5. Princeton reserves the right to accept the highest bid or reject all bids should the highest bid be rejected.
- 6. Acceptance of the highest bid or rejection of all bids will be made by the Princeton Council no later than at its second regular meeting following the completion of the bidding.
  - 7. If Princeton fails to act within said time, all bids shall be deemed to have been rejected.
- 8. If the high bid is accepted, the successful bidder will be required to enter into a Lease consistent with the Bid Package and all other documentation required thereby.
- 9. The Mayor, Administrator, Clerk and other appropriate Princeton staff and officials are hereby authorized to undertake any and all acts and execute any and all documents as may be necessary and proper to effectuate the terms hereof.

The Princeton Police Department initiated a recruitment process in Spring of 2025, attracting over 140 applicants. The comprehensive process included several stages: an open house where applicants could meet officers and learn about the department and municipality; a physical fitness test; screening interviews for those who passed the fitness test; panel interviews involving officers of various ranks; a thorough background investigation; post-background investigation interviews; and interviews with the Public Safety Committee for the top candidates.

The four candidates recommended for employment have excelled in every stage of this rigorous process and exemplify the promise of a bright future for our police department. If the resolution for their appointment is approved, two candidates will begin basic training at the Mercer County Police Academy on September 2, 2025. Following successful completion of their academy training, they will proceed to field training and are expected to be fully qualified for patrol duties by May 2026. The other two candidates are currently Police Commission certified and will begin field training in September 2025 and will be expected to be fully qualified for patrol duties by January 2026.

This recruitment and selection process has been highly successful. We have achieved our objective of identifying a group of highly qualified and diverse individuals who will serve the Princeton community with dedication and excellence for years to come.
