### MEMORANDUM

To: Mayor and Council of Princeton

From: James J. Purcell, Assistant Municipal Engineer Subject: Ordinance to Designate Stop Intersections

**Date:** May 12, 2025

An ordinance to designate stop intersections within the boundaries of the former Township of Princeton is scheduled for introduction at the May 12, 2025 Council meeting. Stop intersections within the boundaries of the former Township of Princeton were designated by resolution of the former Township Committee in the past, as permitted by N.J.S.A. 39:4-140. Since consolidation of the Township and Borough, new stop intersections within the former Borough have been designated by ordinance of the Council. In order to ensure consistency moving forward, it is prudent to ensure that all stop intersections in the municipality are designated by ordinance.

In addition, a study of the intersection of Jefferson Road with Terhune Road recommended that the Jefferson Road approaches be stop conditions, in addition to the Terhune Road approaches. The Engineering Department and the Traffic Safety Committee concur with that recommendation. The number of crashes at this intersection has led the municipality to implement increasing interventions to alert motorists to use caution. Those have included oversized stop signs, double stop signs, stop ahead pavement markings, rumble strips, advance warning signs, retroreflective sheeting on sign posts, and additional sign placards indicating that cross traffic does not stop. These interventions have been implemented in accordance with the guidance from the Federal Highway Authority for a systematic approach to the application of low-cost, proven safety countermeasures. Crashes continue to occur and the introduction of a four-way stop at this intersection is the next step to reducing crashes.

The Traffic Safety Committee, therefore, recommends that this ordinance be adopted and that the new stop condition on Jefferson Road at Terhune Road be included.

#### **ORDINANCE #2025-10**

**ORDINANCE** BY AN THE MUNICIPALITY **OF PRINCETON** DESIGNATING WITHIN **INTERSECTIONS** THE BOUNDARIES OF THE **FORMER** AND **TOWNSHIP AMENDING** CHAPTER 11 OF THE "CODE OF THE TOWNSHIP OF PRINCETON, NEW **JERSEY, 1968"** 

**WHEREAS,** as permitted by N.J.S.A. 39:4-140, stop intersections within the boundaries of the former Township of Princeton were and are designated as such by resolution of the Township Committee; and

WHEREAS, since consolidation of the Township of Princeton and Borough of Princeton, new stop intersections within the former Borough have been designated by ordinance of the Council; and

WHEREAS, to ensure consistency moving forward, the Council seeks to ensure that all stop intersections in the municipality are designated by ordinance; and

**WHEREAS**, at this time the Engineering Department also recommends the inclusion of a new stop intersection in the municipality on Jefferson Road in both directions at Terhune Road.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of Princeton as follows:

Section 1. Chapter 11 of the "Code of the Township of Princeton, New Jersey, 1968," entitled "Motor Vehicles and Traffic," is hereby amended by adding a new section 11-6.3 thereto which shall read as follows:

Sec. 11-6.3 Stop Intersections.

(a) Stop intersections designated. The following intersections in the municipality are hereby designated as stop intersections, pursuant to N.J.S.A. 39:4-140 and N.J.S.A. 39:4-197:







THIS AGREEMENT ("Agreement" or "agreement") is between PRINCETON, a municipal corporation of the state of New Jersey, 400 Witherspoon Street, Princeton, New Jersey, 08540 (hereinafter referred to as "PRINCETON") and Gabrielli Truck Sales, 2306 Route 130 N, Dayton, New Jersey 08810 (hereinafter referred to as "VENDOR").

#### **WITNESS**

WHEREAS, PRINCETON has a need to purchase a 2025 Kenworth T480 Dump Truck with snowplow and sander; and



#### AGREEMENT FOR PURCHASE OF TWO 2025 KENWORTH T480 COMPACTOR TRUCKS

THIS AGREEMENT ("Agreement" or "agreement") is between PRINCETON, a municipal corporation of the state of New Jersey, 400 Witherspoon Street, Princeton, New Jersey, 08540 (hereinafter referred to as "PRINCETON") and Gabrielli Truck Sales, 2306 Route 130 N, Dayton, New Jersey 08810 (hereinafter referred to as "VENDOR").

#### **WITNESS**

WHEREAS, PRINCETON has a need to purchase two (2) 2025 Kenworth T480 Compactor Trucks; and

WHEREAS, on April 21, 2025, PRINCETON received a proposal from VENDOR to provide said goods to PRINCETON for the cost of \$598,941.18; and

WHEREAS, by resolution, the governing body of the Municipality of Princeton awarded a contract to VENDOR without public bidding as authorized by law pursuant to N.J.S.A. 52:34-6.2 b. (3) and in accordance with the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.

NOW THEREFORE, IT IS AGREED by and between PRINCETON and VENDOR as follows:

#### 1. Scope of Services.

- a. In consideration for payment of the cost set forth in Section 3 below, VENDOR shall deliver to PRINCETON two 2025 Kenworth T480 Compactor Trucks, with all standard manufacturer's warranties. The specifications for these goods are detailed in VENDOR'S proposal, a copy of which is attached hereto as Exhibit B and incorporated herein as if fully restated. Should there be any conflict between the terms of VENDOR'S proposal and this Agreement, the terms of this Agreement shall control.
- b. VENDOR's proposal, and the provision of goods and services provided pursuant thereto, are (and shall at all times) be consistent with the terms of the Sourcewell Cooperative Purchasing System Contract #032824-KTC, the terms and conditions of which are incorporated herein as if fully restated.

#### 2. Contract Term.

a. This Agreement shall become effective upon the date of the final signature below and shall terminate upon PRINCETON's acceptance of the equipment and payment to vendor.

#### 3. Compensation.

- a. PRINCETON agrees to pay VENDOR the total sum of five hundred ninety-eight thousand, nine hundred forty-one dollars and eighteen cents. The specific costs attributable to all options on the vehicles are detailed in Exhibit B.
- b. PRINCETON agrees to pay VENDOR within 30 days of the delivery of the equipment, invoice, and executed purchase order to PRINCETON, and PRINCETON's acceptance of the equipment.

#### 4. Terms and Conditions.

a. VENDOR shall take note of and comply with the requirements of N.J.S.A. 10:5-31 et seq. and

- N.J.A.C. 17:27 regarding Affirmative Action/ Equal Employment Opportunity and the Americans with Disabilities Act. The parties hereby incorporate into this Agreement the Affirmative Action/Non-Discrimination addendum per the attached Exhibit A.
- b. VENDOR shall take note of and comply with the requirements of P.L. 2004, c.57 (N.J.S.A. 52:32-44 et seq.) regarding Business Registration and Sales and Use Tax. The parties hereby incorporate into this Agreement the Business Registration and Sales and Use Tax addendum per the attached Exhibit C. PRINCETON will retain the proof of business registration in the file where documents relating to the contract are maintained.
- c. The Terms and Conditions printed on the purchase order issued by PRINCETON to VENDOR shall be incorporated into this agreement.
- d. Only manufactured and farm products of the United States, wherever available, shall be used in connection with this contract, pursuant to N.J.S.A. 40A:11-18.

#### 5. Political Contributions.

- a. This Agreement has been awarded to VENDOR based on the merits and abilities of VENDOR to provide the goods or services as described herein. As this Agreement was awarded through a National Cooperative Purchasing System, VENDOR hereby certifies that VENDOR (including persons and other business entities having an interest in VENDOR, as defined by N.J.S.A. 19:44A-20.7), its subsidiaries, assigns or principals controlling in excess of 10% of the company has neither made a contribution, that is reportable by the recipient under P.L. 1973, c.83, N.J.S.A. 19:44A-1 et seq. (i.e., in excess of \$200.00), in the one (1) year period preceding the award of the contract nor will it make a reportable contribution during the term of this Agreement to any municipal committee of a political party if a member of that political party is serving in an elective public office of the municipality of PRINCETON when the Agreement is awarded, or to any candidate committee or joint candidates committee of any person serving in an elective public office of Princeton when the contract is awarded.
- b. VENDOR is advised of the responsibility to file an annual disclosure statement on political contributions with the New Jersey Election Law Enforcement Commission (ELEC) pursuant to N.J.S.A. 19:44A-20.27 (P.L.2005, c.271, §3) if VENDOR receives contracts in excess of \$50,000 from public entities in a calendar year. It is VENDOR's responsibility to determine if filing is necessary. Additional information on this requirement is available from ELEC at (888) 313-3532 or www.elec.state.nj.us.

#### 6. Hold Harmless.

- a. VENDOR shall defend, indemnify, and hold harmless PRINCETON, its officers, employees, agents, and consultants from any and all claims, suits, actions, damages or costs, of any nature whatsoever, whether for personal injury, property damage or other liability, arising out of or in any way connected with VENDOR'S negligent or wrongful acts or omissions, or those of its officers, employees, agents and consultants, in connection with this Agreement.
- b. It is also agreed that the acceptance of the final payment by VENDOR shall be considered as a release in full of all claims against PRINCETON arising out of or by reason of performance or non-performance of VENDOR'S obligations under this contract.

#### 7. <u>Document Retention; State Comptroller</u>

a. VENDOR shall maintain all documentation related to products, transactions or services under

this contract for a period of five years from the date of final payment. Such records shall be made available to the New Jersey Office of the State Comptroller upon request.

### 8. Contract Documents; Complete Agreement.

- a. The Contract Documents as defined herein are incorporated into this Agreement and made a part hereof by reference. The Contract Documents shall include this Agreement and all exhibits attached hereto, along with the following:
  - i. Sourcewell Contract.
  - ii. VENDOR'S Certification of Investment Activities in Iran, Certification of Non-Involvement in Prohibited Activities in Russia or Belarus and Pay to Play Forms/Disclosures.
- b. This Agreement and any attachments hereto or incorporated by reference represents the entire contract between the parties and shall take precedence over all other prior or existing understandings or agreements, if any, whether oral or written.

Attached for Council's consideration at its May 27, 2025 meeting is an increase to the professional services agreement in the amount of \$34,352.64 with Johnson, Mirmiran & Thompson, Inc. (JMT) for documentation of maintenance holes in flood hazard areas.

JMT is currently under contract with Princeton to collect data on sanitary sewer manholes located within the floodplain. At the project kickoff meeting, Princeton requested that JMT use the recently updated floodplain mapping for the 500-year plus three feet event. This change to the mapping limits increased the number of sanitary sewer manholes by 138 to a total of 538 manholes within the floodplain limits. To date, JMT has been able to visit over 400 manholes but could only collect data on about 80 percent of them due to issues with locating them and opening the covers. After this data collection phase, JMT will update Princeton's GIS sewer database with the new data. They will also be providing Princeton with a list of recommended approaches for making the manholes watertight. Sewer staff will use this information to create a maintenance project which will result in a decrease of inflow and infiltration (I&I) into the sanitary sewer system.

The proposal Johnson, Mirmiran & Thompson (JMT) submitted in June of 2024 included a scope of work to collect data on 400 maintenance holes located within the new Federal Emergency Management Agency (FEMA) 100-year floodplain. Originally, the Municipality had determined that 356 maintenance holes were located within the old FEMA layer. At the time of the proposal submission, prior to investigating the exact number, we estimated that there may be 400 maintenance holes within the new layer. We found that the new FEMA layer produced by the NJ Climate Change Resource Center at Rutgers, in consultation with the New Jersey Department of Environmental Protection (NJDEP), includes 538 maintenance holes. We informed the Municipality of the increase in the number of maintenance holes and the plan was to work efficiently to complete as many maintenance holes as possible within the proposed fee. We were able to visit over 400 maintenance holes but could only collect data on about 80 percent of them due to issues with locating them and opening the covers. We have shared this list with the Municipality so crews can go out and attempt to locate and open these maintenance holes.

We have reviewed our progress to date and the remaining work. We are pleased to submit our fee proposal to complete the additional 138 maintenance holes, the approximately 80 maintenance holes that were not able to be completed and have to be revisited, and the work to turn the GIS map over to the Municipality after all the data collection has been performed.

#### **Maintenance Hole Data Collection**

JMT is proposing to continue with the approach from the data collection phase. This includes having our survey crew collect the GPS locations and rim elevations, and our wastewater staff perform the rest of the data collection. We realized at the beginning of the project that our survey crew can be much more efficient using their GPS equipment, with our wastewater staff following with the inspection and documentation of the maintenance hole details. This worked well to maintain a good pace, and we plan to continue with this approach.

- Our proposal for the survey crew and wastewater staff to complete the maintenance holes that have not been visited assumes that these can be completed at a similar pace. This assumes that the remaining maintenance holes can be easily located and are accessible, including if located on private property, and there are no major satellite issues with the survey equipment. We prioritized the maintenance holes located in wooded areas by visiting these during the winter months when there was little to no foliage. The majority of the remaining maintenance holes are located in open areas or roadways where satellite reception should not be an issue.
- For the maintenance holes that were not found the first time and have to be revisited, we assume that Princeton's crew will join our staff to show us the locations. We do not want our staff to have to revisit any maintenance holes a third time.
- Our wastewater staff will have one (1) member performing data collection and will require the presence of Princeton's crew to open the maintenance holes. We will notify Princeton of any maintenance holes that cannot be located or

opened. We assume the help of Princeton's crew for any minor traffic control or flagging operations for the maintenance holes located in roadways. The standard traffic control measures that Princeton's crews implement for routine maintenance hole inspections in roadways should be adequate. As such, we do not anticipate that any major traffic control measures will be required.

- As we approach the end of the data collection phase and must revisit the maintenance holes that could not be completed when first visited, the pace may be slower since travel time will be required to move from one area to another. On average, we were not able to complete documentation of one (1) in every five (5) maintenance holes visited. We attempted to locate and open these missing maintenance holes, but did not want to take too much time to look for, uncover, or open any since that would reduce efficiency. We figured the best approach was to move on in the interest of maintaining a good pace and revisit these later after Princeton's crews had a chance to go back to these first.
- The maintenance holes we will need to revisit are spread out in various areas of the system. We have been able to maintain
  a good pace by walking the pipeline and collecting data one maintenance hole after another. However, these will not be
  able to be completed in this way and will require driving, which will be a slower operation. Our proposal reflects the longer
  time to complete these maintenance holes.

#### **GIS Map Deliverables**

JMT used shapefiles provided by Princeton to create a GIS map in JMT's ArcGIS online account for data collection of the original 538 maintenance holes. Originally, we intended to collect the data in a handwritten log and input the data later into a JMT created GIS map. We would then turn over a shapefile to Princeton that included all the data collected. This approach would require Princeton to perform some integration of the data into the existing GIS map.

We realized that collecting the data this way would increase the amount of time spent per maintenance hole and would require us to input the data into the GIS map later. We asked JMT's Technology Group to help make our data collection more efficient. Since we were not sure what level of editor permission we could be granted, our Technology Group created a form in Field Maps that could be used by both our surveyors and wastewater staff to collect the data on iPads. Maintenance hole attributes that were not in Princeton's existing GIS map but were asked to be collected were added, such as cover diameter, opening diameter, and frame depth. As per the meeting between Princeton and JMT on April 14, 2025, Princeton will provide JMT owner level credentials to their ArcGIS Online to directly edit the map and import the collected data. The updates will be to the original 538 maintenance holes as well as some that were found during the course of the data collection.

JMT will update Princeton's GIS dataset using a combination of field survey data collected by JMT augmented with as-built documentation that was provided by the Municipality. JMT will perform the following:

- Adjust the x and y coordinates of the maintenance holes to match the GPS location collected by our surveyors.
- Associate all field data collected by appending attribute fields to the existing structure feature class attribute table.
   Maintenance hole attributes will include the rim elevation, upstream and downstream invert elevations, frame and cover dimensions, cover type, maintenance hole material, maintenance hole type, pipe size, and pipe material.
- Generate new point features within the maintenance hole feature class representing the maintenance holes that were
  discovered during the data collection that were not previously mapped. All the attributes listed in the second bullet point
  will be added to the attribute table for each added structure. We will discuss these maintenance holes with the Municipality
  and the identification numbers for these and the ones that do not currently have identification numbers will follow the
  naming convention provided by the Municipality.
- Remove maintenance holes from the sanitary sewer feature class that were found during the data collection to be stormwater and not sanitary.
- Snap the connecting sanitary sewer pipes to the repositioned and/or new maintenance hole point features to maintain proper network connectivity and system topology.

#### Compensation

JMT will provide the above services based on the described approach, for the upset fee limits as follows:

### **Total Estimated Budget:**

\$34,352.64

The cost breakdown for staff is also included for your review. The contract will be a not-to-exceed amount, but with the ability to amend it if more hours are required, however we don't intend to seek additional funding unless something drastically changes with this process.

As discussed in the meeting with Princeton on 3/25/24, reviewing the collected data, analyzing the maintenance holes' existing conditions, and determining the course of action for each maintenance hole (i.e. replacement, raising the cone or barrel, replacing the type of cover) will be performed under a future contract. This effort is not included in this proposal.

We have enjoyed working with the Municipality of Princeton on this project and look forward to continuing our services. ## Resolution of the Mayor and Council of Princeton Authorizing Site License Agreements with Crown Castle Fiber LLC for Two Locations

WHEREAS, Crown Castle Fiber LLC ("Crown Castle") is expanding its network to meet the demands of telecommunications services and has identified two (2) locations in the Municipality of Princeton ("Municipality") on which it wishes to locate, place, attach, install, operate, control, and maintain its equipment in the public right-of-way on facilities owned by the Municipality or owned by third parties; and

**WHEREAS**, Crown Castle and the Municipality entered into a Rights-of-Way Agreement on September 14, 2023; and

WHEREAS, a copy of this Agreement is on file in the office of the Princeton Clerk; and

- 2. **188 Jefferson Road** Located on the west side of Jefferson Road approximately 35 feet south of Guyot Path, a new antenna and associated equipment are proposed on a replacement utility pole, which currently contains no small cell infrastructure, and will serve T-Mobile. The existing 23-foot utility pole will be removed and a replacement 29-ft utility pole will be installed, along with reinstallation of the existing street light. The installation will include an equipment shroud, electrical disconnect, and electrical meter mounted to the pole. The overall height of the proposed antenna is 33'-0".

Attached for your review and consideration are two (2) site license agreements with Crown Castle Fiber LLC and a resolution authorizing the Mayor and Clerk to sign the agreements. Crown Castle works with providers of cellular telecommunications to locate and collocate cell antenna nodes to expand their networks. These site license agreements include nodes to provide both 5G and enhanced 4G cell service to the community to meet the increasing demands on the telecommunications network.


The applications for these two locations have been reviewed and approved through the administrative review process stipulated in the Crown Castle Rights-of-Way Agreement approved by Council on September 11, 2023.

The agreements grant Crown Castle the right to install and attach wireless cellular installations on, under and above the public right-of-way on, in and adjacent to the specific Structure and Infrastructure identified in the attachments to each site license. These particular Agreements pertain to installations within the existing right-of-way at the following locations:

- 1. 8 Winant Road Located at the southwest corner of the intersection of US Route 206 and Edgerstoune Road, equipment on an existing 26-foot decorative metal pole is proposed to be upgraded, which will serve Verizon, T-Mobile, and AT&T. The antenna shroud, ground-mounted cabinet, and two antennas will be replaced and two additional antennas are proposed within the new shroud. Plantings will be provided to shield the ground-mounted cabinet. The overall height of the proposed antenna shroud is 28'-10".
- 2. 188 Jefferson Road Located on the west side of Jefferson Road approximately 35 feet south of Guyot Path, a new antenna and associated equipment are proposed on a replacement utility pole, which currently contains no small cell infrastructure, and will serve T-Mobile. The existing 23-foot utility pole will be removed and a replacement 29-ft utility pole will be installed, along with reinstallation of the existing street light. The installation will include an equipment shroud, electrical disconnect, and electrical meter mounted to the pole. The overall height of the proposed antenna is 33'-0".

**Subject:** Professional Services Agreement with Arcadis for Mini-System #36 Construction

**Date:** May 22, 2025

Attached for Council's consideration at its May 27, 2025 meeting is a professional services agreement with Arcadis to provide construction engineering and contract administration services for the sanitary sewer Mini-System (MS) #36 project.

The MS #36 rehabilitation work has been separated into three distinct construction projects which will be performed simultaneously. The mini-system is very large (8 miles of main, 680 sanitary sewer laterals, and 200 manholes) and there was concern that there would not be a construction company with enough capacity to bid for the entire MS construction. The work is the same in each bid but the contracts are sized for more competition of bidders. The construction scope of work involves the use of trenchless technology to reduce inflow and infiltration (I&I) in the sewer collection system. This is achieved by applying chemical grout to seal leaking joints in sewer mains and laterals, as well as rehabilitating manholes. These measures are designed to prevent groundwater and stormwater from entering the sanitary sewer system, thereby improving its efficiency and integrity. It is anticipated that the three projects can be completed in ten months.

Arcadis, U.S., Inc. prepared the construction documents, and are poised to provide construction engineering and contract administration services for the MS #36 projects over the ten month construction period. The estimated hours assumes that the three projects will occur simultaneously and that duplication of Arcadis personnel is not needed to oversee the work.

# PROFESSIONAL SERVICES AGREEMENT FOR CONSTRUCTION ENGINEERING SERVICES IN CONNECTION WITH THREE MINI-SYSTEM #36 SEWER REHABILITATION PROJECTS

THIS AGREEMENT ("Agreement" or "agreement") is by and between PRINCETON, a municipal corporation of the state of New Jersey, 400 Witherspoon Street, Princeton, New Jersey, 08540 (hereinafter referred to as "PRINCETON") and Arcadis U.S., Inc., with offices at 15 East Midland Avenue, Suite 3E, Paramus, New Jersey 07652 (hereinafter referred to as "CONSULTANT".)

#### **WITNESS**

WHEREAS, PRINCETON desires to obtain Construction Engineering Services in Connection with Three Mini-System #36 Sewer Rehabilitation Projects; and

WHEREAS, on May 2, 2025, CONSULTANT provided a written proposal to PRINCETON for purposes of performing the sought-after professional services to PRINCETON, a copy of which is attached as Exhibit B hereto; and

WHEREAS, by resolution, the Council awarded an agreement for professional services to CONSULTANT without public bidding as authorized by law, in accordance with the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.

NOW THEREFORE, IT IS AGREED by and between PRINCETON and CONSULTANT as follows:

#### 1. Scope of Services.

a. In consideration for payment of the cost set forth in Section 3 below, CONSULTANT shall use its best efforts to perform professional services and other related duties as set forth in the CONSULTANT'S proposal, a copy of which is attached hereto as Exhibit B and incorporated herein as if fully restated. Should there be any conflict between the terms of CONSULTANT'S proposal and this Agreement, the terms of this Agreement shall control.

#### 2. Contract Term.

- a. This Agreement shall become effective upon the date of the final signature below.
- b. This Agreement shall be authorized for the length of time necessary for the completion of the actual construction, unless terminated sooner pursuant to the termination provisions set forth in subsection 2c. below.
- c. The Agreement may be terminated by either party, by giving thirty (30) days advanced written notice to the other, to the address as set forth on page 1 above.

#### 3. Compensation; Manner of Payment.

a. The anticipated cost of CONSULTANT'S services as described herein shall not exceed five hundred forty-one thousand, three hundred twenty-seven dollars and zero cents

(\$541,327.00), subject to annual budgetary appropriations.

- b. CONSULTANT shall bill PRINCETON monthly on municipal vouchers for services rendered and reimbursement for such expenses incurred during the prior month, based on the hourly rates and fees set forth in Exhibit B. CONSULTANT shall give written notice to PRINCETON when the CONSULTANT has billed eighty percent (80%) of the compensation set forth in paragraph 3a.
- c. PRINCETON agrees to pay CONSULTANT within thirty (30) days of receipt of invoice and an audited and approved signed voucher.

#### 4. <u>Terms and Conditions.</u>

- a. CONSULTANT shall take note of and comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 regarding Affirmative Action/ Equal Employment Opportunity and the Americans with Disabilities Act. The parties hereby incorporate into this Agreement the Affirmative Action/Non-Discrimination addendum per the attached Exhibit A.
- b. CONSULTANT shall take note of and comply with the requirements of P.L. 2004, c.57 (N.J.S.A. 52:32-44 et seq.) regarding Business Registration and Sales and Use Tax. The parties hereby incorporate into this Agreement the Business Registration and Sales and Use Tax addendum per the attached Exhibit C.
- c. The Terms and Conditions printed on the purchase order issued by PRINCETON to CONSULTANT shall be incorporated into this agreement per the attached Exhibit D.

#### 5. Political Contributions.

- a. This Agreement has been awarded to CONSULTANT based on the merits and abilities of CONSULTANT to provide the services as described herein. This Agreement was not awarded through a "fair and open process" as that phrase is defined in N.J.S.A. 19:44A-20.7. As such, CONSULTANT hereby certifies that CONSULTANT (including persons and other business entities having an interest in CONSULTANT, as defined by N.J.S.A. 19:44A-20.7) has neither made a contribution that is reportable by the recipient under P.L. 1973, c.83, N.J.S.A. 19:44A-1 et seq. (i.e., in excess of \$200.00), in the one (1) year period preceding the award of this Agreement nor will it make a reportable contribution during the term of this Agreement to any municipal committee of a political party if a member of that political party is serving in an elective public office of the municipality of PRINCETON when the Agreement is awarded, or to any candidate committee of any person serving in an elective public office of the municipality of PRINCETON when the Agreement is awarded.
- b. CONSULTANT is advised of the responsibility to file an annual disclosure statement on political contributions with the New Jersey Election Law Enforcement Commission (ELEC) pursuant to N.J.S.A. 19:44A-20.27 if CONSULTANT receives in a calendar year \$50,000 or more in the aggregate through agreements or contracts with a public entity. It is CONSULTANT'S responsibility to determine if filing is necessary. Additional information on this requirement is available from ELEC at (888) 313-3532 or

#### 6. Insurance; Hold Harmless.

- a. Prior to commencing work, CONSULTANT shall furnish PRINCETON with a Certificate of Insurance as evidence that it has procured such commercial, automobile, workers' compensation, employer's and professional liability insurance coverage as is customary for the type and scope of services to be rendered under this Agreement. PRINCETON, and its officers, employees, agents and consultants, shall be listed as additional insured and as the certificate holder on such policies.
- b. CONSULTANT shall defend, indemnify and hold harmless PRINCETON, its officers, employees, agents and consultants from any and all claims, suits, actions, damages or costs, of any nature whatsoever, whether for personal injury, property damage or other liability, arising out of or in any way connected with the CONSULTANT'S acts or omissions, or those of its officers, employees, agents and consultants, in connection with this Agreement.
- c. It is also agreed that the acceptance of the final payment by the CONSULTANT shall be considered as a release in full of all claims against PRINCETON arising out of or by reason of performance or non-performance of the CONSULTANT'S obligations under this contract.

#### 7. Complete Agreement.

a. This Agreement and any attachments hereto or incorporated by reference represents the entire contract between the parties and shall take precedence over all other prior or existing understandings or agreements, if any, whether oral or written.

During the performance of this contract, the contractor agrees as follows:

The contractor or subcontractor, where applicable will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex.

The contractor or subcontractor will send to each labor union, with which it has a collective bargaining agreement, a notice, to be provided by the agency contracting officer, advising the labor union of the contractor's commitments under this chapter and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

The contractor or subcontractor, where applicable, agrees to comply with any regulations promulgated by the Treasurer pursuant to N.J.S.A. 10:5-31 et seq., as amended and supplemented from time to time and the Americans with Disabilities Act.

The contractor or subcontractor agrees to make good faith efforts to meet targeted county employment goals established in accordance with N.J.A.C. 17:27-5.2.

The contractor or subcontractor agrees to inform in writing its appropriate recruitment agencies including, but not limited to, employment agencies, placement bureaus, colleges, universities, and labor unions, that it does not discriminate on the basis of age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex, and that it will discontinue the use of any recruitment agency which engages in direct or indirect discriminatory practices.

The contractor or subcontractor agrees to revise any of its testing procedures, if necessary, to assure that all personnel testing conforms with the principles of job related testing, as established by the statutes and court decisions of the State of New Jersey and as established by applicable Federal law and applicable Federal court decisions.

The contractor and its subcontractors shall furnish such reports or other documents to the Division of Purchase an Property, CCAU, EEO Monitoring Program as may be requested by the office from time to time in order to carry out the purposes of these regulations, and public agencies shall furnish such information as may be requested by the Division of Purchase an Property, CCAU, EEO Monitoring Program for conducting a compliance investigation pursuant to N.J.A.C. 17:27-1 et seq.

Arcadis U.S., Inc. (Arcadis) is pleased to offer our continued services as experts in trenchless rehabilitation, especially packer injection grouting techniques, to the Municipality of Princeton (Princeton) for the three Mini System-36 (MS-36) Sewer Rehabilitation construction projects. As both third party construction resident engineer/inspectors and as the actual contractor for Construction Manager at Risk projects, the Arcadis staff proposed for this project have undergone extensive training and have overseen and directed hundreds of miles of packer injection grouting, cured-in-place mainline and lateral liners, and manhole rehabilitation projects. It is rare that a consulting firm can make the claim of being uniquely qualified and have that be completely the case, but for this project, it is truth. Regarding packer injection grouting, which is the primary technology of this project, Arcadis' Buried Infrastructure team has no equal. Arcadis' master technical specification for test and seal work formed the basis for National Association of Sewer Service Companies (NASSCO) Capital Grouting specification published in 2021 and our inspector training program is being used to frame the upcoming ITCP-Grouting Certification program. Our knowledge of the technology application will safeguard Princeton's interests.

These projects will restore the extent the life of these infrastructure and sharply reduce the infiltration and inflow (I&I) entering these sewers. Our services will include construction engineering, contractor administration, and inspection services. To allow this work to be completed within a single year given contractor capacity limitation, this work was separated into three separate, simultaneous contracts. The following scope of services will apply to across the three contracts; costs for each contract will be tracked individually to allow separation of expenses and labor to each contract.

This scope and budget covers work from project bid award meeting through substantial completion for all three bid sewer rehabilitation contracts. It does not cover the contract required warranty inspections or warranty evaluations 18 months after Substantial Completion; a separate scope and budget will be prepared ahead of that work.

## **Objectives**

The objective of this work is to collaborate with the successful contractors and Princeton to ensure the construction plans and specifications for sewer rehabilitation using capital grouting techniques in MS-36 grouting projects provide highly effective inflow and infiltration reduction.

## **Assumptions**

This project has approximately 8 miles of mains, 680 laterals, and 200 maintenance holes. An evaluation of production rates anticipates that 3 grouting rigs, one each for each of the three sewer rehabilitation contracts, abetted by sufficient cleaning and CCTV inspection trucks/crews can complete this work in 10 months. Contract time from Notice to Proceed to Substantial Completion is 300 calendar days. This scope assumes 0.5 months for preconstruction activities, 10 months of construction engineering and inspection, and 0.5 months for the contractors to prepare and submit final documents and deliverables.

This scope also anticipates the construction inspector will continue the public outreach initiated during design to ensure homeowner concerns are properly addressed as well as cleanout locating, manhole inspections, roof leader assessment, and basement inspections.

## **Scope of Work**

Successful use of trenchless rehabilitation methods, especially capital grouting, require rigorous evaluation of the contractor's submittals and oversight by knowledgeable, experienced personnel to ensure the work is properly constructed given the field conditions at the time of installation. We will staff the construction oversight of this work with only staff experienced in the capital grouting techniques being used. As a licensed contractor who has built several large grouting projects, we understand this type of construction far better than typical consulting inspectors and usually far better than contractors performing the work, to the point that we usually train the contractor's field staff in the proper installation of capital grouting methods. We know that grout crews will require both significant coaching and sharp attention. The value to Princeton in having Arcadis conduct these services is the peace of mind that comes from knowing a team of engineers knowledgeable and experienced in the design and construction of these technologies, especially with those aspects that prevent construction and post-construction failures, is overseeing the work.

As part of our scope of work, Arcadis will provide construction engineering and contract administration services for the duration of the contract. Arcadis will:

- Review schedules and shop drawing submittals (of which 25 per contract have been assumed) for compliance with the contract documents.
- Provide half-time senior Construction Engineer oversight during first week of grouting for each of the three
  contractors to ensure basic capital grouting techniques are understood by the Contractors.
- Provide full-time Construction Engineer (resident project engineer) during construction operations.
   Construction Engineer will observe the work for compliance with the contract documents and provided required construction engineering input to contractors' work and interpretation of construction specifications and drawings. For the purposes of this proposal, we have assumed the three contractors will generally work with 1 crew each, four days per week for 9 months, and that our construction oversight will require site presence for 8 hours per day.
- Provide regular senior engineerfield oversight. For the purposes of this proposal, we have assumed a senior engineer will be on-site one day per.
- Provide senior oversight remotely daily to construction inspectors and Contractors' crews to successfully guide the work.

- Review Pre-construction mainline inspections conducted by the Contractors that are electronically transferred
  to Arcadis by the Contractors, recommend alternative rehabilitation techniques to Princeton should grouting
  not be the clear choice for rehabilitation, and communicate desired rehabilitation techniques to Contractors.
- Prepare inspectors daily reports (IDRs), update Sequence Tracker, update Manhole Tracker, update Lateral Tracker, update Pay Item Progress Tracker, and update Issues Tracker daily.
  - Because this work is being done under three separate contracts, Arcadis will track the work as three separate construction projects for the purposes of pay basis and for the purposes of Arcadis' charges.
- Consult and provide advice to Princeton during construction.
- Prepare elementary sketches and supplementary sketches to be required to resolve actual field conditions encountered.
- Prepare agendas, report progress, chair meetings, and issue minutes for progress meetings for each contract every 6 weeks.
- Review monthly and final pay estimates submitted by the contractors and prepare recommendations to Princeton.
- Review Post Construction inspections conducted by the Contractors, recommend remedial action or deductions for out-of-specification defects, and prepare punch list.
- Meet with New Jersey Infrastructure Bank (IBank) officials during construction at the project site(s).
- · Review claims and change orders.
- Processing of complaints and releases from citizens.
- Participate in the preparation of the certificates of completion (issued for Substantial Completion).
- Provide Princeton with all inspections and grouting reports, videos, and databases for incorporation into their GIS or CMMS as part of the Record Plan for the project.
- Provide final Sequence Tracker, Lateral Tracker, and Manhole Tracker databases to Princeton for incorporation into their GIS or CMMS as part of the Record Plan for the project.
- Provide any GIS corrections via paper map markups to Princeton.

## **Budget**

For the services, we have divided the work in the following three tasks and propose to complete the work on a time and materials basis a not-to-exceed amount of \$541,327 in accordance with our existing summary of standard charges.

#### **ASSIGNMENT**

Neither party shall assign or transfer this order or any interest therein or monies payable ther under without the written consent of the other party and any assignment made without such consent shall be null and void, except that Princeton may assign this order and its interest therein to any affiliated corporation or to any corporation succeeding to Princeton's business without consent of vendor.

WHEREAS, additional legal services will be needed during the term of this contract; and


WHEREAS, it is anticipated that the additional legal services will not exceed \$100,000.00, bringing the total contract to an amount not to exceed \$265,000.00; and


